Presidential Address

Dear SFA members:

I hope everyone is having a nice summer, despite the usual hot, muggy weather and the unpleasant news about the budget cuts around the state. As I hear about these events, I will post them to our listserv in a timely manner. I hope you will find the time to contact the appropriate state and local officials and let them know how important it is to keep our libraries, archives, museums, and historical societies thriving. As representatives of these organizations, it is up to us to let these

folks do what they can to preserve Florida's documentary heritage.

Despite the financial shortfalls that have affected our travel budgets, I was pleased that we still had a very good turnout for the SFA 25th Anniversary annual meeting. The anniversary presentation at our luncheon was a lot of fun as well as a great tribute to the work of our past SFA presidents. Thank you to all who attended. Our sessions were most interesting and informative, and I personally thank our presenters, vendors, and other supporters who made this meeting a success. From feedback we received, people learned how valuable History Fair can be to our students in acclimating them to primary sources and their importance in research; became more aware of Florida oral history initiatives and the issues surrounding oral history projects; and saw the need to have workable disaster preparedness programs in our institutions. For those of you who couldn't attend, we missed you this year and we understand. Although you didn't have the opportunity to professionally network with other members, I've asked several of our presenters to send me their PowerPoint presentations that I will put on our website in the near future so that at least you'll reap some of the educational benefits of our meeting. You'll also note that the website's home page now features an updated slide show of pictures taken at our recent meeting.

As I begin my second term of office as your President, your Executive Board has been busily engaged in activities that will facilitate our election process and our internal operations. As an example, the Board recently approved an amendment to the Bylaws changing the term lengths of SFA's officers. The previous Bylaws, Article IV, Section 6, which addressed the terms of office for all positions, read:

"The term of office shall be one year and shall commence at the adjournment of the Annual Business Meeting."

It has now been changed to:

"All terms shall commence at the adjournment of the Annual Business Meeting. The term of office for the President and Vice President shall be one year. The term of office for the Secretary and Treasurer shall be three years. The term of

office for the Directors shall be two years, staggered so that one director is elected during odd-numbered years and the other director is elected during even-numbered years."

We examined many other state/regional/national organizations, and found that the most common model is for presidents to serve one-year terms. For those organizations that had two-year terms, most had a presidential one-term limit so that the presidents couldn't serve for more than two years consecutively. We also felt that this would provide continuity for these individuals who, by serving longer, would have an opportunity to perform their tasks more efficiently and would eliminate the need to elect people to these positions on a yearly basis.

According to the current Bylaws, this amendment will remain in effect unless the membership decides to rescind or alter it at next year's annual meeting. At that time, you will also have an opportunity to vote on a general revision of the Bylaws, which your Board will be acting upon this year. We'll keep you posted on these activities through the newsletter and the SFA Listserv.

Looking ahead to the future, our 2009 Annual Meeting Committee has been making plans for next year's meeting in Gainesville, and it promises to be an exciting one. As more information becomes available, I will post it to the website.

SFA members continue to remain active in statewide activities that impact Florida's museum, library, historical, and archival communities. As you may know, the Florida Association of Museums recently received an IMLS grant, "Connecting to Collections: Statewide Planning Grants." Its purpose is (1) to prepare a broad assessment of collections to identify needs in Florida's museums, libraries, archives, and the priority in which they should be addressed, and (2) to educate legislators and decision-makers about their responsibilities to preserve collections held in trust by government entities and private boards across the state. Museums, archives, libraries, and the historical community are represented by the Florida Association of Museums, Florida Art Museum Directors Association, the Florida Library Association, the Florida Public Archaeology Network, the Florida Trust for Historic Preservation, the Florida Department of State, and our own Society of Florida Archivists. Each of these groups serves on a steering committee to insure that the collection assessment represents the broad range of Florida collections and collecting concerns. The planning grant includes forums with museum, library, and archives representatives that will be held in Miami, Orlando, and Tallahassee later this year and in 2009, to obtain as much input as possible about collections' needs.

I am pleased to announce that the first of these three forums will be held on September 6 in Miami, and Michael Zaidman, an Executive Board Director and our newsletter editor, will attend as our SFA delegate. In the fall newsletter, Mike will provide a summary of the discussion points covered at the meeting.

As you can see, SFA remains actively involved in issues impacting Florida's archival and historical community. If you would like to participate in any of these activities, or have any questions or concerns, please let our Board know about them. As described in our mission statement, SFA is here to serve "individuals and institutions who share a concern for the identification, preservation, and use of [Florida's] records of historical value."

Forums Open To Public

Connecting to Collections –

Planning for a Florida Collections Assessment

The 2005 *Heritage Health Index Report* found that American collections are at risk of damage because of improper environmental conditions and storage and are vulnerable to catastrophic loss. 77% of institutions do not specifically allocate funds for preservation in their budgets. The condition of 30 % of artifacts in the nation's collections is not known. What of Florida's collections?

Join colleagues from museums, libraries, archives, and historic and archaeological collections to plan a statewide assessment of Florida's collections and to develop strategies to educate legislators and public officials about their responsibility to preserve and conserve Florida's collections.

The first of three Forums will be held in Miami on Saturday September 6 at the Lowe Art Museum at the University of Miami from 1:30 to 5 pm. The Forum will be followed by a reception for area legislators.

The second Forum will take place in Orlando in the fall, and the third in Tallahassee in March 2009.

This is a collaborative project of the Florida Association of Museums, Florida Art Museum Directors Association, Florida Library Association, Florida Public Archaeology Network, Florida Trust for Historic Preservation, Department of State, and Society of Florida Archivists. Nineteen states received funding from the Institute of Museum and Library Services to plan a statewide assessment. This is Florida's opportunity to assess the state of our collections, and with the results of the assessment in hand, develop statewide policies and identify funding sources to secure Florida's collections. Come help shape this important initiative.

A press conference held on June 2 at the Miami-Dade Main Library was attended by nearly 100 children, as well as the Dolphins' cheerleaders, mascot, and former and current players.

Summer reading programs like the one hosted by the Miami-Dade Public Library System encourage children to use their libraries for recreation and continued learning while school is not in session. The Florida Library Youth Program, which is administered by the State Library and Archives of Florida, is a statewide initiative that brings children and teens to public libraries during the summer, where they can have fun in a friendly, encouraging atmosphere.

The ultimate goals of the project are: to develop an online digital archive of oral histories that give voice to Florida's diverse communities, to design and develop infrastructure to collect, store, preserve, and provide access to oral histories and to collect and disseminate.

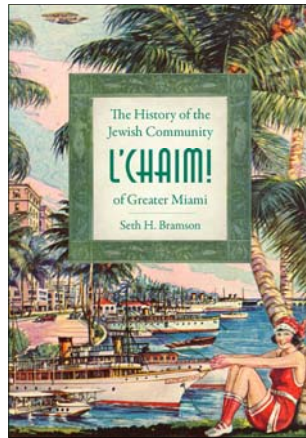

BOOKS/CASE STUDIES RELEASED

Last year, from an undisclosed source, well known Miami memorabilia and Floridiana collector Seth Bramson was given the collections of the family of Miami's first permanent Jewish settler, Isidor Cohen. The collection, numbering in the thousands of items, measured somewhere close to ten cubic feet.

With that collection in hand, Seth set about writing the book

FUNDING

Senate Appropriations Panel Increases Funding for NHPRC and NARA. On July 10, the Senate Appropriations Committee cleared the Financial Services and General Government (FSGG) fiscal year 2009 appropriations bill that includes funding for the National Archives and Records Administration (NARA) and the National Historical Publications and Records Commission (NHPRC). NARA received \$441.6 million, a significant \$41.6 million increase over the FY '08 enacted amount. The NHPRC would receive \$8.5 million for grants and \$2 million for administration. Florida State Archives

In recognition of the 75th anniversary of President Franklin D. Roosevelt's New Deal, the State Library and Archives of Florida re-created a photographic exhibit that was first developed by the Florida Works Projects Administration in 1939. The original exhibit, titled *Conch Town*, documented Bahamian immigrants living in Riviera Beach, Florida. The new exhibit, www.floridamemory.com/PhotographicCollection/photo_exhibits/WPA/, found on the *Florida Memory Project*, includes the 30 original photographs and captions, along with the original catalog and news clippings about the exhibit. The images represent only a small portion of the New Deal-related records and publications found at the State Library and Archives.

In May 1939, Florida WPA photographer and artist Charles Foster accepted an assignment to take photographs for Florida Writers Project writer Veronica Huss' profile of the "Conchs" on Riviera Beach. At the time, locals used the derogatory slang term to describe immigrants from the Bahamas. Armed with his Reflex-Korelle single-lens camera and four rolls of 12-exposure black and white film, Foster spent the day photographing Veronica and her subjects.
